### Public Works Assessments

ICI invoices all member contractors monthly for assessments on public works contracts awarded based on the following formula:

- The first \$2,000,000 of fiscal year contract volume = .20 of 1%
- The second \$3,000,000 of fiscal year contract volume = .10 of 1%
- Fiscal year contract volume in excess of \$5,000,000 = .05 of 1%
