ICI invoices all member contractors monthly for assessments on public works contracts awarded based on the following formula:

The first 2,000,000 of fiscal year contract volume = .20 of 1% The second 3,000,000 of fiscal year contract volume = .10 of 1% Fiscal year contract volume in excess of 5,000,000 = .05 of 1%

ICI currently applies a 30 percent discount to amounts it invoices for assessments on public works contracts. The Board of Directors reserves the right to review this discount.
